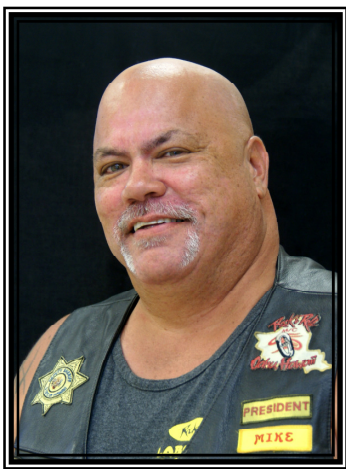

### Message from the Desk of Bruce Paige, SBU State Director



Aloha Members:

Well the elections are over and it might seem like nothing has changed. There was no new nominees elected only incumbents who had no challengers to their incumbent offices. That could mean that no one was actively participating in the elections and no one really cares! I have been told by some persons whose identities shall remain anonymous "That no one wants the positions of SBU Officers, so anyone who runs is automatically in and no elections are even necessary!"

I am here to say categorically that is just not true. First, we had a full slate of incumbents running for every office available in the Maui and Oahu Chapters. At the State level we actually had to create two new elected positions to recognize the important influence that Ray Pagan, State Treasurer and Marie Bashaw, State Membership Committee Chair, bring to SBU's statewide profile. There are many new faces on both the Maui and Oahu Chapter Boards, although they are all well known to the local motorcycle communities, because most of the SBU officers of the various Chapters are past or present MC Officers, HOG Officers or independents actively involved in the Hawai'i motorcycle community. They are a hard working dedicated and loyal group of riders,

who put the rights and interests of their fellow motorcyclists first. They prove it by volunteering their valuable time to be SBU Officers. I am proud to work with and be associated with each and every one of these Chapter and State Officials. They really do care and they show it by their efforts and commitment to the SBU membership.

The outcome of the elections is also a clear indication that the membership is interested in what the SBU executives have done and are doing. We have the first formal elections in at least ten years. There has been occasional efforts to have a vote on something or other in the past, but this was really different. These elections were official, according to the constitution and we had the largest membership participation in our history. Yes, there were no actual races for office, but who cares all the offices are filled for the first time that anyone can remember. Also, we had our first absentee voting, which had twice the voter turnout of the "in-meeting votes", which was great. That is democracy in action. Next time it will be even better as more members participate.

Our members now have more ways than ever to communicate with the executive and with each other: whether it is online, through the SBU Website Membership chatroom, the SBU Online Calendar, SBU Facebook and of course face-to-face at our meetings and runs. There has never been a time in SBU's history when it has been as politically active as it has been in the last few years and this has paid off with less adverse-motorcycle legislation going to third readings or "crossing over". This is a trend that we can hopefully maintain by greater membership growth and participation in SBU events and activities statewide. Rick Davis always said "United we stand, divided we fall". It is often an overused phrase. Even a cliché. Yet for SBU, it is a political reality. We are reminded by politicians all the time that our success in opposing bills which adversely affect bikers' interests is directly related to how many members SBU has and how much public opposition we can generate from our membership's active opposition to those unwanted helmet, stock muffler, noise violation, proposed registration fee hikes and safety check regulation bills that the legislators annually try and throw at us.

I know you might think we overstate the importance of growing our membership numbers, but nothing could be farther from the truth. In politics numbers are everything and SBU is a political advocacy organizations, so we are in the numbers game; like it or not. We need every member to do their part by bring in more members and making sure your membership is renewed. That is the minimum we ask for our commitment to you and your fellow riders that we will do everything in our power to keep Hawai'i Street Bikers United and riding as free as legally and politically possible.

**The Legal Corner by Bruce Paige, Esq**

I though the members might appreciate it if I dealt with some of the legal topics that come up either at meetings and my discussions. For my first topic I am going to deal with the currently “hot issue” of protecting intellectual property (often abbreviated to “IP”) and in particular motorcycle club’s names and logos (i.e. the “Patch”). Before getting started I wish to make the usual “lawyer’s disclaimer” that: *the following are solely my own views and not those of SBU\**. *This is a general discussion and Not Legal Advice, which is always dependent on the specific facts of a particular client’s case. You should always consult legal counsel to be sure of how these issues affect you and if they are applicable to your particular case.*

With that aside I would like to hit a few of the “high points” of how individuals, clubs and associations might be affected by either infringing upon another party’s IP or some other party infringing on their IP. This topic is very broad and for the sake of brevity, our discussion will be limited to the IP rights owned by the holder and user of a name and logo incorporated into a club or association Patch.

We have all heard stories of how some motorcycle clubs (often call “motorcycle gangs”), to convey they are one per cent “Sons of Anarchy type” organizations, deal with anyone who uses, copies or represents themselves to be associated with that motorcycle gang (by using, wearing and displaying the gang’s name and/or logo). It usually involves some combination of treats, violence and physical and/or property damage to the pretender or non-member (i.e. the “Infringer”). This approach obviously, in most cases, discourages any further “infringement” on the gang’s right to exclusively use, wear and display their name and/or logo. Although this form of protection is often very effective it is also very illegal and is in fact criminal.

So what legal steps can an individual, motorcycle club or association do to protect their names and logo’s (as appearing on their patches for example), from being infringed upon by other parties? In other words how can they legally protect their club name and logo? Also, what can individuals or clubs and associations do to avoid infringing on other parties IP rights in a “Trademark”, “Trade Name” or “Service Mark”? Well the list of steps is so long and involved that I cannot go into any real detail, but I am going to list some of the better known steps and procedures in ascending order of cost and simplicity.

1. Two of the infringement cases I am familiar with in Hawaii involving MCs both involved the clubs own members, as dissidents, who became disaffected, separated from the club and claimed either the club name or the logo or both as their own. Regardless of who is right and who is wrong in cases involving litigation over the IP rights to the names and logos (whether as unregistered Trade Names, Service Marks, or Trademarks), except in the world of “big business” where millions are spent creating, promoting and advertising names and logos recognized by the consuming public, no one usually wins an infringement case except the lawyers who get paid handsomely to prosecute or defend the infringement case. Everyone else pays dearly to fight over something that although very important to them never usually justifies the costs of the litigation. However, something as simple and inexpensive as a restrictive covenant signed by every club or association member declaring the club, association or its founder owns the name and logo, agreeing never to use, claim any right in or represent any ownership of the trademark or logo, is usually sufficient legal deter most potential infringers. Ultimately, if they do infringe the club, association or founders as beneficiary of the covenant have a clear right to sue for breach of the covenant as well as an independent right to sue for the infringement.
2. Most clubs or associations are unincorporated organization, some of which may have charitable status under the Internal Revenue Code (IRC) 501(a) and (c)(4). This is recognition of the unincorporated organization as a “legal entity”. The club or association may be involved in fundraisers and charitable events or activities which create good will and recognizable value in the club or association name, logo or event that is recognized at common law as an unregistered Trade Name, Trademark or Service Mark. Although the common law may recognize the holder or user or a Trade Name or Trademark as having a right of use if they seek to establish sole ownership and exclusive rights of use to it, there are strict rules on what must be done to protect its rights by exclusive and continuous use. Also, a party claiming their common law IP rights are protected as an “unregistered trademark” can never be sure those rights will be upheld and enforce by a court until they actually go to court and those IP rights are actually upheld. So usually parties choose a more inexpensive and reliable route to be sure their Trade Name or Trademark is enforceable by registering it.
3. If a club or association is not a registered charity, does not have a formal constitution, charter or some other official documentation creating it as a legal entity then how does it establish its right to and ownership of its name and logo on its patch? First, if it registers its name as a “Trade Name” with the Hawai’i Department of Commerce & Consumer Affairs (“DCCA”) Business Registration division (“BREG”) that creates a legal right to the name, which will be recognized as long as the registration is maintained. (The cost is nominal approximately \$50.00 and can be done online).

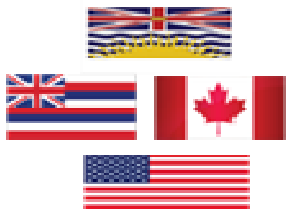

4. The club, association or founders can register the domain name and this will again establish the right to use the name and website that is owned by the registrant. (Cost approximately \$25.00/year). It will generally discourage others from using the name either inadvertently or intentionally, since the more forms of registration, ownership and control of a name the less useful to others and more risk of being successfully sued for infringement.
5. There are two types of trademark registration federal and state. The federal trademark registry is more expensive, time consuming and more procedurally complicated. Its advantage is that it gives the federal trademark holder a ten year exclusive right to the trademark (the "Mark" as it is called) upon registration for the entire country. (The simple Trademark registration fee starts at \$275, but there are other costs for art work, legal costs, etc). The state trademark registration system is much less expensive (state registration fees start at \$50.00/application), simpler, faster and require less legal work if a lawyer is involved. The state registered trademark is limited to five years protection (it can be renewed just as the federal Mark), but the state Mark is only protected within the state boundaries. For most clubs and associations the statewide protection is all that is usually necessary, unless they have mainland chapters.
6. Incorporation is another means of registering a name and specifically excluding it from use by any other parties. Although, the incorporation may be effective in protecting the name, which cannot be registered by any other party as a Trade Name, Trademark or by incorporation, it is more expensive and complicated than a simple Trade Name or state Trademark registration. With an incorporation there are additional administrative expenses, corporate minute books, resolutions, annual meetings and accounting requirements. Incorporation may not make sense for some clubs and associations, which are only concerned with protecting their name and logo.
7. Before closing I want to make one further point which a lot of people don't understand about registering trademarks (whether federally or in the state system). It is still subject to rules, just like the common law, only more clearly defined in most cases. Therefore, first the owner of a Trademark or Service Mark must protect their exclusivity or ownership by continuously using the Mark. They cannot use it sometimes and other times use some other name or logo. Second, the Mark owner must defend the mark from any form of infringement. That means if some other party uses the patch name or logo in part or in whole the club or association must sue the infringer to protect their exclusive right to the Mark. It is no excuse to say it cost too much money to protect the Mark. If a Trademark owner stands by and allows others to take and use their Mark it will be at risk of being deemed "abandon" and therefore no longer exclusively owned by the holder. So pick your name, logo, and club members carefully, because if you want to register a Trademark you must be prepared to defend it as exclusively used by you as owner.

Remember, when riding into a corner always look where you want the bike to go. Similarly, for legal matters do some investigation, get some advice and decide where you want to go before you start. It will save you time and money in the long run.
