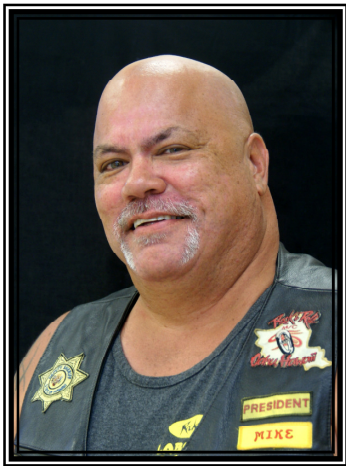

Message from the Desk of Bruce Paige, SBU State Director

It seems like a very long time since I have had to sit down and report to you on SBU matters, but sometimes no news is good news. I am happy to report we have been making reasonably good progress on a number of projects.

Since this is November and SBU Toy Runs on Maui and Oahu are only a month or so away, I will start with SBU Toy Run related matters. Maui Chapter under the very capable leadership of President Ron Panzo, has been doing more fundraisers and local events than ever. Ron is really busy with two restaurants now, but he has an amazing group of loyal members and an executive that all pull together and get the job done while having fun doing it. Maui has never been stronger financially and organizationally. This year's Maui Toys for Tots event will undoubtedly be bigger and better than ever. I encourage everyone to get out and support Ron and the gang in Maui. I am going to encourage some of our Oahu Chapter and State Executives to see if we can make it over to Maui this year to help support and encourage the Maui Toys for Tots event, which is the weekend after

the Oahu Toys for Tots event on Sunday December 4th.

The Oahu SBU Toy Run/Parade should be as big as ever, maybe even bigger. SBU State Treasure and Webmaster, Ray Pagan, has always been the principal coordinator of the Oahu event and this year is no different. However, we have been working on a few projects and ideas to expand both the Toys for Tots event and the SBU membership drive simultaneously. We even got some helpful input from Mo'Opuna O' Hawai'i President, Roy Gomez, (a past SBU Director himself) on this project. What we are going to do for this years' Toys for Tots event is make it free (yes you heard it) to SBU members in good standing, who apply for the wrist band on or before November twentieth. After November 20, SBU members pay \$3.00/band if pre-ordered and \$5.00/band at the event. No person will be allowed to participate in the event without a wrist band and no unlicensed, unregistered or uninsured bikes can participate in the ride.

Just to further encourage our membership drive we have also agreed for 2017, that SBU memberships will be slashed in half to \$10.00/year and anyone who has already paid \$20.00 for the 2017 year can write/email Ray Pagan (the address in on our website) and get credit for an extra year (i.e. 2017 & 2018), but you have to actually contact Ray to make sure it is noted on your membership record. Additionally, Ray Pagan and the State and Oahu Chapter executive, are going to present a second event on Sunday, June 4th, 2017 as a part of our membership drive. The date is set, the venue will be the FRA (Fleet Reserve Association 891 Valkenburgh St. Honolulu, HI), for those of you that don't get out to our SBU monthly meetings. There will be fun, food, activities, probably a ride and entertainment. The details of the June membership event will be disclose as they firm up. With Ray coordinating it you know it will be well organized. We want to get our members to bring out potential members and get them signed up. The push for expanding the SBU membership will also be supported by the new State Chair for both Membership and Public Relations, Robert (Thumbs) Thomas, Oahu Chapter Vice-president. Marie (Honu) Bashaw, will stay on as State and Oahu Chapter secretary and give Thumbs any support he might need as he gets up to speed as the State Membership and PR Chair.

One of the reasons we are pushing so hard for membership, is that we have got nowhere after two years of trying to work with the State DOT regulators to get some regulatory provision for shoulder use on the freeways, to deal with the bikes overheating problems associated with gridlock. Some of the political connections that we have developed over the years have suggested there is not much hope of getting a serious response from the legislature without a large membership support. By large numbers they are talking in the thousands. We have decided to go for the "gusto" and implement our own SBU supported legislation, focused on Motorcycle Lane Filtering (MLF"). It is a little different than California style "lane splitting", which SBU's political advisors have said is a strict "no go" for Hawaii legislators. The goal is to develop the proposed MLF bill (which is already in draft form) and support it with a 5,000 SBU membership petition. Yes it is ambitious, but if we get 5,000 bikes out for the Toys for Tots Parade on a good year, then what if all the participants were signed up as members? Our political allies in the House and Senate tell us that those kinds of numbers can get a bill passed. Ok let's see if we can do it. We'll keep you posted on the membership numbers and you need to get everyone you know that rides involved and signed-up as a SBU member. Together, if we can get that kind of support for the petition, SBU will embark on a political PR and advertising campaign to further inform the public and support the proposed SBU Bill. With hard work, genuine commitment and some serious membership numbers Hawaii could be the second state in the country to have a version of MLF legislation and we would all be the better for it. It would reduce the risk of rider injuries due to rear-end collisions, eliminate the risks, or injury and damage to bikes and riders being stranded on freeways due to overheating problems, and contribute to reducing traffic congestion as motorcycles filter through stopped traffic. Keep those membership applications coming in people, we are told a 5,000 membership petition is the magic number to drive this kind of legislation.

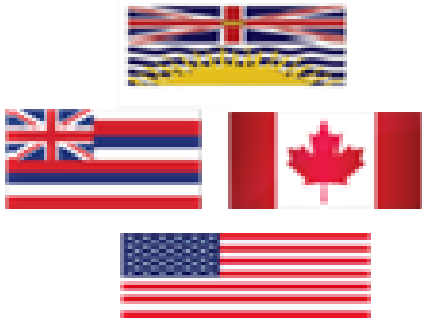
